



YOUTH ON TRACK CYCLING / J.A.M. PARTICIPATION AGREEMENT

This Agreement applies to all Youth On Track Cycling and J.A.M. activities, including mountain biking, BMX, cycling, coaching, trail work, camps, events, races, transportation, and J.A.M. activities involving mini dirt bikes, electric motorcycles, off-road motorcycles, and related training.

1. Activities Are Voluntary

I understand participation is voluntary. I or my child may choose not to participate in any activity that feels unsafe or uncomfortable.

2. Assumption of Risk

I understand these activities involve serious risks. These risks include falls, crashes, collisions, jumps, rough terrain, equipment failure, rider error, instructor error, weather, dehydration, wildlife, transportation accidents, and delayed emergency response.

For J.A.M. and powered-vehicle activities, I understand there are additional risks, including throttle malfunction, brake failure, battery failure, fuel exposure, fire, burns, electrical hazards, rollover, loss of control, and crashes involving mini dirt bikes, electric motorcycles, or off-road motorcycles.

I understand these risks may result in serious injury, emotional injury, property damage, permanent disability, paralysis, or death.

3. Safety Rules

Participant agrees to follow all rules and coach instructions. Participant agrees to wear required safety gear, including a helmet, eye protection, gloves, long sleeves or pants, protective footwear, and any required body armor.

Participant agrees not to use any bike, motorcycle, e-moto, helmet, or safety equipment that appears damaged, unsafe, improperly fitted, or not working correctly.

4. Medical Permission

If emergency medical care is needed, I authorize YOTC/J.A.M. staff, coaches, or volunteers to seek emergency medical treatment. I accept financial responsibility for medical costs.

5. Release of Liability

To the maximum extent allowed by Arizona law, I release and agree not to sue Youth On Track Cycling, J.A.M., their officers, directors, coaches, volunteers, sponsors, churches, property owners, instructors, event organizers, affiliates, and agents for claims arising from participation, including claims based on ordinary negligence.

This Agreement does not release claims that cannot legally be released under Arizona law, including claims based on gross negligence, willful misconduct, or intentional misconduct.

6. Indemnification

I agree to defend, indemnify, and hold harmless the released parties from claims brought by me, my child, family members, heirs, estates, insurers, or third parties arising from participation in YOTC/J.A.M. activities.

7. Transportation

I understand transportation to and from activities may involve risks, including traffic accidents and loading or unloading equipment. I authorize transportation when arranged by YOTC/J.A.M., its coaches, volunteers, or approved drivers.

8. Photo/Media Permission

- Yes, I allow YOTC/J.A.M. to use photos or videos of the participant for promotional purposes.
 No, I do not allow photo or video use.

9. Parent/Guardian Consent

For minor participants, I certify that I am the participant's parent or legal guardian and have legal authority to sign this Agreement. I understand that minors may participate in cycling, BMX, trail, and J.A.M. powered-vehicle activities with heightened risks.
